



- Option 2: **File Upload** - Submit tag and animal information, including animal birth dates, through a spreadsheet file. (Best option for dial-up users)





2. Web services update:

The following web services will be supported with the REST API:

- Birthdate Certificate Management
- Account Management
- User Management
- Inventory Management
- Premises Management

All SOAP based web services will be discontinued by March 31, 2020.

3. Expand On-Hold transaction to All Animal Event Types:

Currently CLTS creates an on-hold transaction if the event type is Retired or Exported, and tag has not been issued. This is being expanded to all the animal events (Birthdate, Move In, Move Out, Imported, Replaced, Temp Export, Disposed, Cross Reference). Event will be on-hold until the tag is issued. This will minimize the errors and users do not need to wait for the tag issuance to submit the transaction.
